By implementing Egnyte Connect <sup>SM</sup> for Google Drive, organizations are able to complement their Drive investments in four major areas – Storage, Users, Applications and Management:

- Storage: Access and manage files stored in Drive and on-premises devices (SAN/NAS/DAS), including EMC, NetApp, NETGEAR, Synology, Windows File Server and more.
- Users: Expand team collaboration to non-Google users and external team members with enhanced security and IT controls.
- Applications: Extend Google Apps investments with Egnyte's integrations that improve Line-of-Business (LOB) processes and serve unique vertical needs.
- Management: Ensure that admins maintain full visibility over 100% of files kept in group storage and user devices.

# ADMIN-CONTROLLED COLLABORATION

### INTEGRATE ON-PREMISES STORAGE

# USE CASE: EXTENDING ENTERPRISE ADMINISTRATION

### **GROUP STORAGE**

All group data and file shares can be stored in a company-wide group storage space in Drive to prevent data silos from forming in an organization. Users gain quick access to critical data regardless of where the data is physically stored. This also enables users to extract more actionable insights from audit reporting that spans across 100% of files.

# AUTOMATIC PROVISIONING AND DEPROVISIONING

When an employee or contractor leaves an organization or an external user leaves a team, access and ownership of shared files are automatically retained by the administrator. Since users authenticate Egnyte through Single Sign-On (SSO) services with Google Drive for Work, access to all corporate files is immediately revoked.

#### **FNTFRPRISF-WIDE ADMIN CONTROLS**

Egnyte's powerful dashboard provides deep administrative control over file

services for Drive and on-premises storage. These controls can be viewed and leveraged from a single interface that can be accessed from any device. Admins are able to provision users and groups, set notifications, manage usage policies, add integrations, and control security and privacy settings.

#### POLICY-BASED SYNC

Leveraging Storage Sync, admins can set policies to prioritize the syncing of files to offer immediate access to essential data. Sync can be prioritized by the most recent version or by file types, and admins can also exclude certain file types, making relevant data available when and where employees need it.

# USE CASE: EXTENDING BUSINESS CONTINUITY AND COMPLIANCE

#### COLLABORATION WITH LIMITED BANDWIDTH

Storage Sync allows files in Drive to be instantly synced to local storage devices, keeping collaboration running smoothly, even when bandwidth is limited or connectivity has been compromised.

### PRIVACY AND COMPLIANCE

Egnyte provides world-class protection for storage, sharing and access to corporate data across all of its file services offerings. Storage Connect allows files that are too sensitive to move to the cloud to remain on premises behind the corporate firewall. This addresses privacy concerns and maintains compliance with government and industry regulations, including FINRA, HIPAA, EU Safe Harbor and more.

# STORAGE BACKUP

Syncing of files through Storage Sync across Drive, on-premises storage and other cloud repositories provides enterprises with an extremely cost-effective backup solution that can be audited and controlled from one centralized panel. All syncing across Drive and local storage is delivered with distributed redundancy.

### **USE CASE: EXTENDING PRODUCTIVITY**

### CROSS-PLATFORM COLLABORATION

Users are able to seamlessly view, create and edit Google Docs and other documents from a single interface. In order to collaborate with users who may not have Google accounts, Google users no longer have to install multiple cloud storage and sharing solutions. With drag-and-drop ease, users can interoperate between files in Drive and Egnyte via the desktop clients.

### WEBEDIT WITH EXPLICIT FILE LOCKING

Egnyte provides a powerful WebEdit tool that enables users to view and edit documents in their native applications, outside of Google Drive for Work files. WedEdit can be used on any mobile device to enhance productivity and mobile collaboration with a full suite of office productivity and industry apps including Salesforce, AutoCAD, DocuSign and more.

### SECURE REMOTE ACESSS

To avoid incurring high costs and lost time due to migrating legacy data to the cloud and the burden of managing a cumbersome VPN, enterprises can use Storage Connect to keep files in on-premises storage while still enjoying cloud-like benefits (i.e., simplified collaboration, sharing and mobile access). Enterprises can also use Storage Connect to access files from any device without requiring FTP and VPN setups.

#### **ECOSYSTEM AND APIS**
